



## Request for Proposals (RFP) – 3000 Gallon Jet A Refueler Truck

The County of Marquette (County), Marquette Sawyer Regional Airport (SAW), seeks proposals from qualified vendors to provide one (1) Jet A refueler truck with approximately 3,000 gallon (11,350 liter) capacity in accordance with the specifications listed below. Proposals must be received no later than **Wednesday February 11, 2026 at 11:00 a.m. EST**. Vendors shall submit the documents using the **Proposal Form** contained in this Request for Proposal (RFP) by mail or in person in a sealed envelope, which identifies the proponent and states “**Marquette Sawyer Regional Airport 3000 Gallon Jet A Refueler Truck**” on the outside of the envelope. Proposals must be delivered to: Airport Services Center, 125 G Avenue, Gwinn, Michigan 49841. Proposals will be publicly opened and read aloud at 125 G Avenue, Gwinn, Michigan 49841 at the date and time specified below.

All RFP’s are due by the time specified. Any RFP received at the designated location after the required time and date specified for receipt shall be considered late and non-responsive. The County is not responsible for delays occasioned by the US Postal Service, the internal mail delivery system of the county, or any other delivery method employed by the Vendor.

## TECHNICAL PROVISIONS

1. A new and/or used 3,000 Gallon (1 ATA 103 and NFPA 407 compliant 1,350 Liter) Jet A Refueler
2. ATA 103 and NFPA 407 compliant
3. Diesel engine; automatic transmission
4. 300 GPM (1,135 LPM) dispensing system
5. Underwing and overwing reels (Single wound reel, one overwing and one underwing)
6. Fueling Hoses shall be new within the most recent quarter
7. New API 1529 fueling hoses installed with test certificates with permanently coupled hose fittings.
8. Filter/Water Separator vessel with water defense and with most current revision of filter/separator(s)
9. Bottom loading with high-level shutoff
10. Static bonding reel, brake interlock system, pressure control system (primary and secondary), emergency fuel shutoff system
11. Control panel with nozzle pressure gauge, pump pressure gauge, and differential pressure gauge with three-way test valve
12. Two (2) new 20 lb BC fire extinguishers Look up the required fire extinguisher, NFPA 407
13. Two (2) new BC NFPA 407 compliant fire extinguishers
14. Install Single Compartment Scully System, Scully system plug should be located near bottom load filling adapter
15. Full flow and operation test performed prior to delivery with accompanying test documents
16. Complete wiring and plumbing diagrams
17. Warranty information to be provided with proposal
